For the lease of a horse to be recognized by the Appaloosa Horse Breeders' Society of South Africa, whether for breeding, showing or performance purposes, the lease must be filed with the AHBSSA, **signed by both the lessor and the lessee**, and submitted with a fee of R50. The lease shall provide the name, registration number, and a complete date the lease took effect and may provide a termination date. It may otherwise be terminated by a written notice, **signed by both the lessor and the lessee**, which gives the termination date; or by the properly executed transfer report which shows a change of ownership from lessor to the lessee. If the horse is sold to anyone other than the lessee, a termination must be submitted to the AHBSSA office. No additional charge is required for termination whether it is automatic or by subsequent notice thereof. All leases should be filed with the AHBSSA.

In regard to AHBSSA procedures, the recording of a lease authorizes a lessee to execute all documents pertaining to the recognized activities of breeding, showing, or performance.
